Waiver

I hereby acknowledge my voluntary participation in Draper Days Humans & Hounds Wellness 5K event (walk or run) (the "Event") at New River Trail may result in personal injury to me, any minor under my care, and/or my dog(s) "Dog".

By participating in, attending, or observing the Event, I acknowledge and assume all risks and dangers that are incidental to or in any way arise from the Event including, without limitation, all risks and danger inherent in a canine-oriented event (e.g. dog bites, fights or altercations, falls, and contact with participants or spectators at the Event) and in the sports of walking and running. I understand that walking and running in races are potentially hazardous activities, which could cause injury or death.

I agree to abide by any decision of an Event official relative to my ability to safely complete the Event. I assume every risk associated with participating in the Event including, but not limited to: falls, contact with Event participants or volunteers or with vehicles or dogs, the effects of the weather, including high heat and/or humidity, traffic and the conditions of the road and course. I consent to emergency medical care and transportation in the event of injury and to obtain treatment medical professional may deem appropriate. I accept personal responsibility for any and all actions of the Dog and agree that the Dog will be in my care, custody, and control during the Event. I hereby represent and confirm that the Dog is in good health, current on Rabies, and that the Dog is not the subject of a quarantine order, a pending adjudication or administrative hearing, and has never been declared a dangerous, potentially dangerous or vicious or potentially vicious dog.

We highly encourage all dogs participating in this activity to also be vaccinated for other transmissible diseases, such as parvo, distemper, and bordetella, and to be current on a proper parasite preventative that treats both internal and external parasites to protect the health of your pet and all other participants.

I agree to be bound by the terms of the rules and regulations established by the Event. I will abide by all applicable governmental laws, ordinances, orders, directions, rules and regulations, as well as all rules and regulations that are adopted for this Event. I acknowledge that the Event reserves the right to exclude or eject any and all unruly, rowdy, or disruptive participant, dog owner or Dog from the Event and that I shall be fully responsible for any damages or expenses, direct or indirect, incurred as a result of myself or my Dog's disruptive behavior and/or ejection. I further agree that any Event official may authorize necessary treatment for me and/or the Dog in the event of injury. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release Thee Draper Village, the town of Draper, the Commonwealth of Virginia, all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver.
